## WHAT IS LAF AND WHY ARE WE SUPPORTING IT?

AAUW champions and advances equity for women and girls through a variety of programs and initiatives. We know about scholarships and research fellowships and pay equity rallies and Title IX support and buying radium for Marie Curie. But why are we asked to raise money for LAF? How does the Legal Advocacy Fund fit into the wider AAUW framework?

We can find an answer in the mission statement: AAUW Legal Advocacy Fund provides funding and a support system for women seeking judicial redress for sexual discrimination. "Funding" is self-explanatory, but the support system is equally important. LAF started in 1981 with a pilot program to support women seeking justice for gender discrimination. That pilot became the <u>Legal Advocacy Fund</u> (LAF). LAF has provided millions of dollars to balance the scales of justice for people working toward gender equity through the legal system.

#### A case must meet these minimum requirements for consideration:

- 1. Be filed in state or federal court, preferably at the appellate level
- 2. Address sex discrimination in the workplace or academia, including topics like unfair pay, tenure or promotion denial, pregnancy discrimination, Title IX violations, and sexual harassment or sexual assault
- 3. Have the potential to set or reinforce precedent for future cases on gender discrimination

LAF supports brave plaintiffs seeking legal redress for <u>Title VII</u>, <u>Title IX</u>, <u>equal pay</u>, <u>sexual harassment</u>, <u>and tenure denial violations</u>. The Fund allocates \$100,000 annually to help fund landmark cases such as *Wal-Mart v. Dukes* and *Cioca v. Rumsfeld* as well as cases with the potential to set future precedents, such as *Rizo v. Fresno County Office of Education*.

For our plaintiffs, LAF goes beyond financial support. LAF can provide organizational support as an amicus signatory or other statement of support. LAF offers plaintiffs emotional support, a family of AAUW members present at significant legal proceedings.LAF provides advice and information to individuals with question about their rights on campus and in the workplace with regard to gender discrimination, harassment, and assault. LAF Case Support Travel Grants make it possible for members to meet AAUW plaintiffs and advocates and hear their stories at AAUW state and regional conventions.
