Implement Paid Leave and Paid Sick Days: an issue of AAUW's Gender Agenda

Unlike most developed countries worldwide, the U.S. does not guarantee paid time off for illness, family care or parental leave. The nation's lack of paid sick and family leave is endangering both the physical and economic wellbeing of countless American families.

- **Federal**: pass the Family and Medical Insurance Leave (FAMILY) Act and the Healthy Families Act.
- **Pennsylvania:** pass the Family Care Act paid leave insurance program, HB1739 and SB580 which have bi-partisan support in both the house and senate.

The Bucks County Women's Advocacy Coalition (BCWAC) is this webinar's host. Panelists include the Family Care Act campaign's Marianne Bellesorte from Pathways PA, an AAUW-PA Gateway to Equity Award winner. The event features messages from Family Care Act sponsors, Rep. Wendi Thomas, (R-178). and Sen. Maria Collett (D-12). This legislation is bipartisan.

This will be a Zoom webinar where you will be able to ask questions or simply listen in. The event is free, but you must register in order to participate.
