# Fraud, Scams, and How to Prevent Them With David Shallcross

The Program Team



David Shallcross, Director of Senior Protection in the PA Office of the Attorney General presented a program filled with valuable information to protect against scams and fraud. He talked about the three factors that criminals use against their targets:

- Emotional triggers: A phone call from grandson saying "help, I'm in trouble and need money"
- Timing: Friday just before banks close saying your account has been hacked.
- Psychology: "You won the lottery "or "I'm collecting for a charity."

## Some valuable suggestions included STOP, PAUSE, THINK, and VERIFY!

- Call your grandson, the bank or credit card company (use the number on your statement, not the one the caller provides. Did you enter a lottery. You can't win if you didn't. Does the charity exist? When making a donation remember that approximately 60% of donations go to marketing. Every charity must be registered with PA Dept. of State and charities are graded. Validate the charity.
- Don't answer a call if you don't recognize the number and don't think you can outsmart the caller by trying to trick them.
- If the caller is asking too many personal questions and wants to know your account or social security number it's a fraud.
- Don't click on an unknown link or email message. Don't respond. Block &Delete!
- If you don't know anything about a product like Crypto Currency don't invest!.
- Don't just use pass-words. Use pass-phrases. Jack & Jill went up the hill. J&Jwuth, the more difficult the password, the more security.

There were many more topics and suggestions - Mr. Shallcross was a wealth of information! If you think you've been scammed, don't be afraid or embarrassed to contact the police or the Senior Protection Unit 866-623-2137. Often, money can be recouped if notified within 48 hours.

## **Public Policy**



#### **CHECKS and BALANCES**

Our founding fathers wrote the constitution as a framework for our democracy. It established these key principles:

- \*Separation of Powers: Dividing government authority among the legislative, executive, and judicial branches.
  - \*Checks and Balances: Giving each branch specific rules and responsibilities.
- \*Federalism: Dividing powers between the federal government and the state government.
- \*Protection of Individual Rights: Guaranteeing fundamental rights and liberties to citizens.

The legislative branch (Congress) makes the laws that deal with money the government spends. Congress must be in agreement before the bill goes to the President. If vetoed it is returned to Congress. Congress can then override the veto or the bill dies. If the President signs it, the bill becomes law. It's the Judicial Branch's responsibility to see that these laws are followed. Each branch has equal authority and all three work together where the CHECKS and BALANCES ensure that our country runs properly.

The last two months have brought chaos to our federal government. The executive branch is ignoring the laws written by Congress. The Executive branch is also ignoring the Judicial branch. Congress is giving up its power to rein in the president. The court is a slow process. The famous quote by Benjamin Franklin, when asked if we have a republic or a monarchy, "A republic, if you can keep it," comes to mind. The foundation of our democracy is threatened when these CHECKS and BALANCES to keep our three branches of government EQUAL are ignored. We are steadily moving in this direction. Our founding fathers must be rolling over in their graves.

I will not be submitting an article for the May Bylines due to the Book Fair, so here is a little pep talk about the upcoming Primary on May 20, 2005. We might be feeling helpless when it comes to DC politics, but you can have a real say in local government. As Bill White reminded us when he spoke in February, there are few reporters left to cover our townships, cities, and county meetings. These reporters are the CHECKS and BALANCES on our local governments. It's up to us to attend these meetings. To keep those elected officials accountable to "We the People." Find out who is running for County Executive, County Commissioner, Mayor, City Council, School Board and State Judges. I have heard many of the candidates speak and am happy to give you my opinion. Do your research and VOTE on May 20<sup>th</sup>!

### **The Frozen River** -by Ariel Lawhon

This is an historical fiction thriller by Ariel Lawhon and follows Martha Ballard, a midwife and the medical professional in the town of Hallowell, Maine. She uses her medical insights to investigate two crimes: a murder and a rape. The Kennebec River begins to freeze in the winter of 1789, and a corpse floats down it and becomes trapped in the ice. Martha arrives to examine the body. She identifies it as Joshua Burgess and determines his cause of death to be murder. Martha has knowledge to much of what goes on behind closed doors in Hallowell. She keeps a diary containing every birth, death, and crime that has happened in this town. She documented the details of an alleged rape committed by two of the town's most respected gentlemen and one of them is now dead.

## AAUW Condemns Executive Order to Dismantle the U.S. Department of Education

The American Association of University Women (AAUW) unequivocally condemns President Trump's executive order "Improving Education Outcomes by Empowering Parents, States, and Communities" dismantling the U.S. Department of Education. "This reckless and shortsighted action threatens to gut vital protections that ensure equal access to higher education and will have devastating consequences for students — especially women, students of color, and those from low-income backgrounds — who rely on federal oversight for their right to an equitable education," said Gloria L. Blackwell, CEO of AAUW. "Eliminating the Department of Education would decimate federal civil rights enforcement, slash protections against gender-based discrimination, and roll back decades of progress toward making higher education accessible and affordable. This decision is not about streamlining government; it is about stripping students of their rights and futures."


