**Non-Traditional Study Grant Application Guidelines**  
**Applications are for either one semester or for a complete school year.**

**Adult female residents of the Lehigh Valley who have had their studies interrupted before obtaining their degree are eligible to apply for our Non-traditional Student Study Grant. Applications should be submitted after acceptance into a college or vocational undergraduate or graduate program.**

1. Women applying must be U.S. citizens and legal residents of Lehigh or Northampton Counties.
2. Applicant must:
  - a. Have had her studies interrupted at some point for at least six months
  - b. Have completed the equivalent of one semester of college or vocational schoolwork
  - c. Be attending or have been accepted for the 2025 fall term at an accredited two- or four-year institution, advanced degree program or vocational school
3. Grant award is based on the following criteria (not necessarily in order of importance):
  - a. Demonstrated financial need
  - b. Academic record
  - c. One (1) character reference from non-family member, mentor, or friend.
4. As part of the process, each applicant may be asked to meet the Scholarship Committee for an informal interview. The applicant will be contacted to arrange a convenient time and place.
5. Recipients will be notified as soon as possible after the application has been received and reviewed and a check will be sent to the recipient.
